Fully compliant with IEC61131-3 and programmable with LogicLab, the ECU combines robustness (IP6K8) with advanced diagnostic and maintenance functions, managing networks of sensors, actuators, and solenoid valves in agricultural machinery.

HY Series: efficiency “Made in Parma”

The HY gear pumps and motors, manufactured at Hydreco’s Parma plant, are a hallmark of robustness and versatility. Available in aluminum or cast iron, they cover Groups 1, 2, and 3, with displacements from 1 to 61 cc and pressures up to 260 bar. Modular design and customization options make them suitable for a wide range of agricultural machines.

Other motion control products will also be presented at the booth, including hydraulic joysticks and foot pedals, power units, sectional valves, and hydraulic cylinders, completing Hydreco’s comprehensive offer.
